- There will be a MANDATORY dress rehearsal before our performance.
- **Fall Session:** A \$15 production fee will be due before the performance.
Spring Session: A costume will be ordered for your dancer upon signing this contract, and you will be required to purchase it before the performance. Costumes generally cost between \$45-75.
- Your dancer MUST attend the last class before the show in order to perform with the class.
- A MANDATORY parent meeting will be held before each performance. If you cannot be there in person, you must send a representative adult to attend and collect important info.
- Tickets to our performance will go on sale in advance, and the reserved section will sell out quickly.
- Tuition is due in full regardless of missed lessons or tardiness. Please make class attendance a priority.
